Mr. Maibach is a Distinguished Fellow on American Federalism with Save Our States. So, what is a State Defense Force?

Most of us have never heard of a <u>State Defense Force</u> (SDF) even though about half the states have one. Just recently, Florida reactivated theirs (since 1947) which is called the <u>Florida State Guard</u>.

These military organizations, sometimes called "Home Guards", are authorized by federal law, but created, controlled, and funded by each individual state. Operating under Army protocols, they are solely under the control of the Governor and state adjutant general.

Created to fill in for National Guard units that are deployed, usually overseas, SDFs are prepared to respond to state emergencies and mobilized mainly for disaster recovery missions, which can be very beneficial for states that often face natural calamities. Unlike federal forces, SDFs can be mustered quickly and effectively utilizing the local knowledge possessed by the soldiers, and they integrate well with first responders in the community.

With a median age between 45 and 60 years old, State Defense Force ranks include civilians of all stripes and former members of the military. Trained in emergency management, SDFs are comprised of volunteers who may be compensated for their expenses when called into active duty by the Governor.

These modern state militias, with a history going back to the founding of our nation, are instituted on the tradition of the citizen-soldier, the concept where an individual is trained and prepared to assist a neighbor in need as a matter of civic duty. For former state legislators, an SDF might provide an opportunity to continue serving your state and fulfill your patriotic duty.
